Exclusions:

The prize does not include the following

- Transportation to the Le Boat Base. Winner must make their own way to Le Boat Base.
- Pre or post night accommodations
- Collision Damage security deposit (*due at the base*)
- Meals and onboard cleaning kit
- Bike, kayak or stand up paddle boards (*available to rent*)
- Early Check-in or Late Check-out
- Personal travel insurance

Eligibility:

- Contest is open only to US & Canadian Travel Agents (not applicable in Quebec).
- Contest opens on May 1, 2019 and closes July 12, 2019.
- One ballot per booking.
- Immediate family members of any officers, directors, and employees Le Boat and its affiliates, as well as any residents of their households are not eligible to enter.

- The prize winner will be notified by email. Le Boat shall have no liability for any winner notification that is intercepted, undeliverable or not received by a potential winner for any reason. If, despite reasonable efforts, a potential prize winner does not respond within five (5) days of the first notification attempt, or if a prize or prize notification is returned as unclaimed or undeliverable to such potential prize winner, such potential prize winner will forfeit the applicable prize and an alternate prize winner may be selected. - **Travel dates are based on availability.**

When departing on the holiday:

Security Damage deposit is required at time of check-in at the base. The prize voucher excludes optional holiday extras, travel to and from the departure base and personal travel insurance.

PRIZE/ODDS: The Prize consists one 3 night Le Boat Horizon 1 cruiser rental on The Rideau Canal, Fuel for 16 hours, Boat Cleaning, Mooring and Lock Fees, and Damage Waiver. Choice of itinerary will be provide to the winner at time of booking. Travel dates are based on availability. Black-out periods apply. The total approximate retail value ("ARV") of the Prize is \$2620 (CND) or \$2075 (USD). Estimate prize value is based on June 2019 departures. (Price will vary based on availability and time of travel).

Actual odds of winning are dependent on the number of eligible entries received. **The Prize winner must possess all required travel documents, including visas and valid passports, if and as applicable, and comply with any applicable Le Boat check-in requirements, such as presentation of a major credit card to cover ancillary or optional expenses that may not be included with the Prize.**

The Prize winner is responsible for his/her own transportation to and from the Le Boat Base, which shall be selected by Le Boat. The dates of departure and return are subject to change Le Boat's sole

discretion. The Prize winner will not receive cash or any other form of compensation if actual travel costs are less than the estimate made in these Official Rules.

Pre-/post-hotel accommodations, meals, damage waiver, travel insurance, fuel deposit, internet charges, other fees and taxes are not included and if applicable must be paid at the time of check-out by the winner/guest. A deposit or payment in advance, or presentation of a credit card by the Prize winner, may be required at the time of check-in. Once travel dates are confirmed, the Prize winner is solely responsible for any cancellation or change fees, including that of the travel companion, as specified by the General Information & Conditions as per Le Boat's Terms and Conditions.
